IV. SRA REPORT - Ken Baldeosingh

- > 2017 registered 2835 referees, 41 instructors, 55 assessors, 78 assignors.
- > 2018 registered 1717 referees, 29 instructors, 51 assessors, 77 assignors.
- > Referee Day at the Crew, Saturday, July 21, 2018.
- > Carlos Cordeiro has been elected President of U.S. Soccer.
- ➤ OSYSA is converting to Blue Star for Risk Management in the fall of 2018.
- > Procedure for out of state referees to officiate in Ohio South is posted on website.
- > D1- 645 recertified for 2018. Working on 20% discount for 2018 FC game tickets for 5 specific dates. Club meetings, still having parent issues. 25% of new referees attended mentoring program.
- > D2-435 recertified for 2018, 552 for 2017. Registration ~79% of 2017. 3 Entry level clinics w/39 participants, 25 signed up for one day clinic.
- > D3-717 recertified for 2018. 604 referees registered in 2017 have not recertified. Held 13 recertification clinics, adding 2 clinics. Scheduled 4 Entry level clinics.
- ➤ D4- Two recertification clinics scheduled. ~35% of 2017 referees are not recertifying.
- ➤ D5- 97 recertified for 2018. Held 4 recertification clinics, ~50% of 2017. One recertification clinic scheduled in March.

- > 62 Grade 8 referees recertification clinics scheduled in Ohio South for 2018. Three additional recertification clinics are scheduled in March.
- ➤ 1219 referees registered in 2017 have not recertified in 2018.
- > 67 referees attended the third and final recertification clinic for grades 6, 7 and 15 on February 17, 2018. Fifteen (15) grade 6, thirty six (36) grade 7, six (6) grade 8 and ten (10) Emeritus referees completed their requirements.
- > 9 new instructors completed their requirements at the Entry Level Instructor clinic on January 14, 2108.
- > 40 Instructors have recertified for 2018.
- > 19 Entry Level Clinics have been scheduled for the sring season. District 1=6, District 2=3, District3=9 and District 5=1.
- > 14 new Futsal referees successfully completed training on December 17, 2017. Total Futsal referees = 23 for 2018.
- ➤ 48 members attended the second recertification session for Instructor and Assessors was held on January 6, 2018. Thanks goes out to Chico Grajeda and Michael Salyers for inviting Alan Black of PRO as the guest speaker.

- > D3- Entry level clinic participation is excellent. Plan to add 2 rectification clinics due to low numbers.
